No.18/4/DC(DEO)/TBL/COND/2014: Whereas, the DC/DEO, Thoubal has been designated as the Returning Officer (RO) for No.II-Outer Manipur (ST) Parliamentary Constituency by the ECI for conduct of the General Elections to the House of People vide Election Commission of India's Notification No.434/MR/2009 (1) dated 21-01-2009;


2. Whereas, the following Officers have also been designated as the Assistant Returning Officers (AROs) for No. II-Outer Manipur (ST) Parliamentary Constituency by the ECI for conduct of the General Elections to the House of People vide ECI's Notification No.434/MR/2009 (2) dated 21-01-2009;

- i) DC/DEO, Tamenglong,
- ii) DC/DEO, Senapati,
- iii) DC/DEO, Ukhrul,
- iv) DC/DEO, Chandel,
- v) DC/DEO, Churachandpur,
- vi) ADC/Kangpokpi,
- vii) ADC/Jiribam,
- viii) ADM/Thoubal,
- ix) SDO/Thoubal &
- x) SDO/Kakching

3. Whereas, as per Sub-Section (2) of Section 22 of the Representation of People Act, 1951, the above 10 (ten) election related Officers may be authorised by the RO to perform any of the functions of the RO in respect of No-II-Outer Manipur (ST) Parliamentary Constituencies subject to the Control of the Returning Officer provided that no Assistant Returning Officer shall perform any of the functions of the Returning Officer which relate to the scrutiny of nomination papers unless the Returning Officer is unavoidably prevented from performing the said function;

4. Whereas, in view of the aforesaid provisions of the Representation of People Act, the 10 (ten) Officers listed at Para 2 above are hereby authorised to perform any of the functions of the RO in respect of No-II-Outer Manipur (ST) Parliamentary Constituencies subject to the Control of the Returning Officer. However, no Assistant Returning Officer shall perform any of the functions of the Returning Officer which relate to the scrutiny of nomination papers unless the Returning Officer is unavoidably prevented from performing the said function;

5. In view of the above, the aforesaid 10(ten) Officers are hereby requested to kindly take appropriate action and act accordingly pertaining to the Assembly Constituencies falling under their respective jurisdiction under intimation to DC/DEO, Thoubal [RO for No.-II-Outer Manipur (ST) Parliamentary Constituency].
