No. 20/12/DC(DEO)/TBL/ELEC/MCC/2014/¹⁸¹ With the enforcement of the Model Code of Conduct w.e.f. 5th March, 2014 following the announcement of Election Schedule to the General Elections to 16th Lok Sabha-2014 by ECI on 5th March, 2014 and in pursuance of Para 14.4 of Compendium of Instruction on Election Expenditure Monitoring (January, 2014) issued by the ECI, the DC/District Election Officer, Thoubal held an urgent meeting of the representatives of all recognized National and State Political Parties functioning in the State today, the 8th March, 2014 at 11.00 a.m. at the Conference Hall of DC/DEO, Thoubal.

2. DC/DEO, Thoubal made a power point presentation thereby explaining the process of expenditure monitoring, legal provisions relating to election expenditure and consequences of non-compliance of these provisions. All representatives present were provided relevant copies of the ECI Press Note dated 05-03-2014 (announcement of election schedule), Expenditure Monitoring Instructions, latest & revised Model Code of Conduct, revised format of Affidavit Form-26 etc.

2. The representatives present were also requested to mobilize their Booth Level Agents (BLAs) with a request to extend their maximum co-operation, assistance and help to the Booth Level Officers (BLOs) of all 366 Polling Stations of 10 (ten) Assembly Constituencies falling under the jurisdiction of DC/DEO, Thoubal in connection with the Special Campaign being organized at all 366 Polling Stations tomorrow i.e. **the 9th March, 2014 (Sunday)** to ensure that all left out eligible persons who may be enrolled as voter and those genuine electors whose names have been deleted wrongly are enrolled/re-enrolled so as to enable them to cast their votes in the current Lok Sabha Elections-2014.
