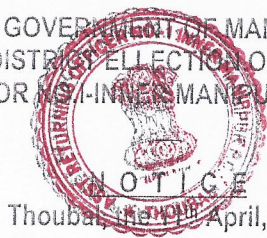

No.20/26/ELEC/DC (DEO)/TBL/LS/2014 : In pursuance of Para 11.14 of Hand Book for Returning Officer (2014-Edition) and to enable the voters residing in 3(three) A/Cs of 30-Lilong, 31-Thoubal and 32-Wangkhem of Thoubal District falling under No. I-IMPC to cast their votes on 17th April, 2014 through Election Duty Certificate (EDC), it is hereby notified for information of all concerned more particularly the voters detailed for election duty in the above 3(three) A/Cs that if they desire to cast their votes through EDC, they may apply in Form-12A for issue of EDC to their respective SDOs/AROs of Thoubal and Lilong during the office hour on or before 14-04-2014.

2. Those concerned voters on election duty who wish to apply for EDC while submitting their application (Form-12A) should enclose a photocopy of the appointment Order to prove his appointment in election duty. As for the security personnel residing in above 3(three) A/Cs who are detailed for election duty, while applying for EDC should enclose a copy of the order assigning them on election duty attested by the SP/Thoubal and Commandant, 3rd IRB. In case of the drivers, cleaners etc. residing in the above 3 A/Cs (detailed for election duty), the concerned authorities (RO/ARO/DTO, Thoubal) may issue the duty slip which shall be enclosed along with the prescribed application Form. Any application received without any supporting document and received after the prescribed dateline shall not be considered.
