**Thoubal, the 18<sup>th</sup> July, 2013**


No.8/82/DC(TBL)/COMMITTEE/NGO/2013: In view of numerous applications/representations received from various Non Government Organizations (NGOs) functioning in Thoubal District requesting the Deputy Commissioner, Thoubal to forward their applications/representations/Detailed Project Reports (DPRs) to various Ministries of the Government of India for grant of financial assistance to these NGOs for taking up various programmes related to different line Departments and with a view to streamline the functioning/working of these NGOs and to ensure that these NGOs perform their assignments/functions and deliver their services to the general public of Thoubal District, it is hereby ordered that a Committee consisting of the following concerned District Level Officers and headed by the Deputy Commissioner, Thoubal is hereby constituted with immediate effect and until further orders in the interest of general public:

i) Deputy Commissioner, Thoubal	-	Chairman
ii) Superintendent of Police, Thoubal	-	Member
iii) Addl. Deputy Commissioner, Thoubal	-	Member
iv) Chief Executive Officer, Thoubal Zilla Parishad	-	Member
v) All Sub-Divisional Officers, Thoubal District	-	Members
vi) Chief Medical Officer, Thoubal	-	Member
vii) District Social Welfare Officer, Thoubal	-	Member
viii) Zonal Education Officers, Thoubal & Kakching	-	Members
ix) District Youth Co-ordinator/NYK, Thoubal	-	Member
x) Joint Director, Veterinary, Thoubal	-	Member
xi) DPO (ICDS)/Thoubal	-	Member
xii) District Planning Officer, Thoubal	-	Member
xiii) Sub-Deputy Collector (HQ), DC's office, Thoubal	-	Member Secretary

2. Depending upon the nature of the works/projects/proposals being taken up by the NGOs, the Committee may co-opt any such Officer as deem fit from time to time.

3. Every application/representation received from the NGOs will be sent to the concerned Department/Office for causing necessary enquiry on the spot by at least 2(two) responsible Officers of the Department/Office and they should submit their detailed report to the Deputy Commissioner/Thoubal stating that the project/proposal being taken up is feasible, workable and reasonable along with their justified reasons and supporting documents. If any of the application/representation is not recommended by the Inquiry Authorities, then they should submit the justified reasons in writing.

4. On receipt of such proposals after the necessary spot enquiry by the Officers concerned, the Member-Secretary of the Committee will examine and compile all such cases and the same will be finally considered by the above Committee and the Committee after due deliberation and detailed examination will take appropriate necessary action as deem fit. Only those applications/representations/proposals which are duly approved/recommended by the above Committee will be forwarded to the concerned line Department of the State Government for taking up further necessary action from their end. Such Committee Meeting will be held at least once in a month. The decision of the Committee will be final.
