
Subject: By-Election to 38-Hiyanglam Assembly Constituency, 2014-Monitoring of printing of pamphlets and posters etc.

Sir,

With the announcement of Election Schedule for the By-Election to 38-Hiyanglam Assembly Constituency, 2014 by the Election Commission of India on the 12th September, 2014 and in pursuance of para(5.7.1) of Compendium of instructions on Election Expenditure Monitoring (January, 2014) and as per Section 127-A of RP Act., 1951, I am to inform that any kind of violation of the existing guidelines/instructions of ECI on the above subject, by any of the printing press located in the Kakching Sub-Division as regards the printing of pamphlets, posters etc. would invite stern action including the revocation of the license of the printing press under the relevant laws of the State Government.

2. Further, you are directed to indicate clearly in the print line the name and the addresses of printer and publisher of any election pamphlets, posters and such other materials printed by your press. It is to inform that copy of the printed material and the declaration of the publisher as required under section 127A(2) of RP Act. 1951 should be sent by the printer to the SDO/RO, Kakching and if it is printed outside Kakching Sub-Division or in State capital (Imphal), then it should be sent to the CEO, Manipur within three days of such printing.

3. In view of the specific direction of ECI, you are requested to kindly comply with the above instruction/guidelines so as to avoid any kind of stern action from the authority.


