No.DeGS(TBL)/e-DIST/2013: In pursuance of letter No.3/11/2012-DIT dated 28<sup>th</sup> May 2013 of the Department of Information Technology, Govt. of Manipur, applications in the prescribed forms are invited from the intending and eligible candidates for engagement of one E-District Manager for implementation of the E-District Project under the National e-Governance Plan (NeGP) in respect of Thoubal District on contractual basis initially for a period of 1(one) year, which may be reviewed for extension on year-to-year basis for a further period of 2(two) years subject to satisfactory performance or for such periods as decided by the Department of Information Technology, Govt. of Manipur based on the performance of the E-District Manager on payment of remuneration of Rs.23,500/- per month (i.e. Rs. 5,200 + Grade Pay of Rs.2,800/- + Rs.15,500/- as Performance Based Honorarium).
