No. 4/65/DC(TBL)/2009/L & O/Pt.-III: Whereas, a report has been received from Superintendent of Police, Thoubal vide letter No. 9/22(DC-TBL)/2013/SP-TBL/2824 dated 21-07-2013 stating that there is apprehension of breach of peace in Thoubal District as the Joint Action Committees (JACs) formed in connection with the recent death of one Master Md. Najimuddin (11 yrs.) s/o MV. Riyajuddin of Sora Chingya Khunata Chingjin at Kakching Lamkhai, PS – Kakching, Thoubal District on 18-07-2013 and there is every likelihood of breach of peace and disturbance of public tranquility in the whole of Thoubal District;

2. Whereas, the prevailing law and order situation in Thoubal District has been reviewed and examined minutely and the undersigned in my capacity as the District Magistrate of the District is fully convinced and satisfied that there are sufficient reasons/grounds for passing a prohibitory Orders under Sub-Section 2 of Section 144 of Cr. P.C.

3. Whereas, it has become expedient to issue prohibitory orders for prevention of breach of peace, disturbances to public tranquility and danger to human lives and properties and to prevent riot or affray;

4. Whereas, there is emergency and circumstances do not permit the serving of notice upon the public in due time, and hence, this order is passed ex-parte under Sub-Section 2 of Section 144 Cr.P.C. and is directed to the public in general;

5. Now, therefore, I, Shri T. Ranjit Singh, IAS, District Magistrate, Thoubal in view of the tense and very volatile atmosphere prevailing in Thoubal District following the death of Master Md. Najimuddin (11 yrs.) as stated above and in exercise of powers conferred under Sub-Section 2 of Section 144 Cr. P.C. do hereby prohibit assembly of 5 (five) or more persons who are likely to turn unlawful in the areas which is described in the schedule given below and also prohibit carrying of sticks, stones, firearms and weapons w.e.f. 22-07-2013. The orders shall take effect from 10.30 a.m. today i.e. 22-07-2013.

6. This order shall not apply to agencies of the Government involved in the enforcement of law and order and the maintenance of essential services.

7. Persons who want to take out procession for marriage, funeral and religious purposes etc. within the scheduled area may apply to the undersigned for permission and they shall not take out procession until and unless the permission is obtained.

8. Copies of this order be pasted on the notice board of the District Magistrate, Thoubal and Superintendent of Police, Thoubal and copies may also be sent to the DIPR, Manipur, DDK/Imphal, AIR/Imphal and ISTV, Imphal for causing wide publicity.
