O R D E R S

Thoubal, the 29th November, 2013

No. 4/65/DC(TBL)/ 2009/L & O/ Pt-III : Whereas, report has been received from the Superintendent of Police, Thoubal stating that KCP (M) is organizing a rally/march holding light (Meira) from 20.00 hrs of 29th Nov, 2013 to 30th Nov, 2013 vide his letter No.9/22(DC-TBL)/2013/SP-TBL/5524 dated 28-11-2013. In view of the prevailing law and order situation in Thoubal District, he has requested to promulgate Prohibitory Orders under Section 144 Cr. P.C. in the whole areas of Thoubal District,

2. Whereas, the prevailing law and order situation in Thoubal District has been reviewed and examined minutely especially in view of the aforesaid report of the Superintendent of Police, Thoubal and the undersigned in my capacity as the District Magistrate of the District is fully convinced and satisfied that there is apprehension of breach of peace in Thoubal District and there is every likelihood of breach of peace and disturbance of public tranquility by some anti social elements taking the advantage of the above proposed Rally/March, being organized by the KCP (M) and there are sufficient reasons/grounds for passing a prohibitory Orders under Sub-Section 2 of Section 144 of Cr. P.C. As such, it is a fit case for imposition of prohibitory orders in the whole areas of Thoubal District under Sub-Section 2 of Section 144 Cr.P.C. to prevent any kind of eventuality,

3. Whereas, the undersigned has already issued a prohibitory orders of even No. dated 08-10-2013 in the whole areas of Thoubal District effective from 6:00 a.m. of 09-10-2013 and the said order also covers the entire whole areas of Thoubal District. In view of the existence of the said prohibitory orders, there is no necessity of issuing another prohibitory order covering the whole areas of Thoubal District,

4. However, in view of the sensitive and volatile nature of the case and the proposed Rally/March and to ensure that the lives and properties of all the general public, it is hereby ordered that the District Police Administration, Thoubal should take up all preventive and precautionary measures to ensure that the lives and properties are protected and no untoward incidents occur in the entire whole areas of the District. The Superintendent of Police, Thoubal is requested to make all necessary arrangement accordingly.

5. Now, therefore, I, Shri T. Ranjit Singh, IAS, District Magistrate, Thoubal in view of the volatile atmosphere prevailing in Thoubal District and in view of the likelihood occurrence of violence and breach of peace as stated above and in exercise of powers conferred under Sub-Section 2 of Section 144 Cr. P.C. do hereby prohibit assembly of 5 (five) or more persons which are likely to turn unlawful in the areas which are described in the Schedule given below and also prohibit/ban carrying of sticks, stones, firearms, weapons and other explosive materials etc. w.e.f. 20.00 hrs of 29th Nov, 2013 onwards until further orders. The orders shall take effect from 5.30 p.m. of 29-11-2013.

6. This order shall not apply to agencies/officials of the Government involved in the enforcement of law and order and the maintenance of essential services.


7. Persons who want to take out procession for marriage, funeral and religious purposes etc. within the Scheduled areas may apply to the undersigned for permission and they shall not take out any kind of procession/rally etc. until and unless the permission is obtained in this regard.

8. Copies of this order be pasted on the notice boards of the District Magistrate, Thoubal and Superintendent of Police, Thoubal and copies may also be sent to the DIPR, Manipur, DDK/Imphal, AIR/Imphal and ISTV, Imphal for causing wide publicity.


