
NOTIFICATION

Thoubal, the 26th September, 2013.

NO.4/33/CAF & PD/TBL/FP/2013: In continuation of this office Notification of even No. dated 19-01-2013 and in view of the decision of the State Government, which has extended the term of appointment of the existing FPS Agents and S.K. Oil Sub-Dealers upto 31-12-2013, it is hereby notified for information of all concerned that fresh applications in the prescribed Format (available in the office of DSO/CAF & PD, Thoubal) are invited from the willing and eligible individuals, Women's Self Help Group/Society, Self Help Group federation, Co-operative Societies, Village Panchayats and Urban local bodies for appointment of FPS Agents and S.K. Oil Sub-Dealers for a period of two years w.e.f 01-01-2014 to 31-12-2015, which may be extended for further period as deem fit depending upon their performance in respect of all the identified zones of Thoubal District, the details of which are available in the office of DSO/CAF & PD, Thoubal, Notice Board and the district website of Thoubal District. As notified earlier, preference will be given to the following categories:-

- i) Preference shall be given to rural local bodies i.e. Gram Panchayats/Village Authorities willing to carry out the functions of FPS/SKO Sub-Dealer or to women SHG/Society, SHG federation, Co-operative Societies etc.
- ii) Preference for appointment of FPS/SKO Sub-Dealer shall also be given to existing General/Grocery Stores selling non-PDS items in villages and willing to carry out the function of FPS/SKO Sub-Dealer by imposing restriction in the sale of non-PDS wheat, rice and levy sugar.
- iii) As far as possible, a single dealer for all PDS items i.e. FPS Agents and SKO Sub-Dealers should be preferred and explored.

2. The other terms and conditions prescribed vide this office Notification of even No. dated 19-01-2013 regarding appointment of FPS Agents and SKO Sub-Dealers will remain same. Those willing and eligible individuals, Women's Self Help Group/Society, Self Help Group federation, Co-operative Societies, Village Panchayats and Urban local bodies should apply in the prescribed format and the same should be submitted to the office of DSO/CAF & PD, Thoubal on or before 21st October, 2013. While submitting the applications, the details of the Zone/Zones mentioned at Para above should be mentioned clearly. Any clarification/doubt/detailed information may be obtained from the office of DSO/CAF & PD, Thoubal during the office hours.
