
No.4/33/CAF&PD/TBL/NFSA/2013: In pursuance of the Secretariat, Consumer Affairs, Food & Public Distribution (CAF & PD) Department, Govt. of Manipur Order No.48/2/2013-CAF & PD dated 26-12-2013 and as per the decision of the of the State Cabinet taken on 26-12-2013 and in order to expedite finalisation of the Priority Houses for implementation of the National Food Security Act, 2013 in Thoubal District, the 3(three) SDOs of Thoubal, Lilong and Kakching Sub-Divisions have already issued notifications calling for claims and objections from all concerned more particularly the general public to the draft list of Priority Houses identified/verified by them, which are available in their respective offices, Notice Boards etc vide their Notification No.4/SDO/(TBL)/FCS/2012 dated 20-01-2014, No.10/SDO/LIL/FCS/2014 (Pt) dated 20-01-2014 and No.5/10/2013-SDO(K) dated 21-01-2014 respectively with a request to submit their claims and objections within a period of 7(seven) days from the date of publication of the Notifications mentioned above.

As the dateline given by the 3(three) SDOs had already been lapsed and in order to ensure that no eligible Priority Households are left out before the final list of Priority Houses is published/notified by DC/Thoubal, another opportunity of filing of claims and objections is hereby given once again to all concerned more particularly the general public to raise/lodge their claims and objections to the draft list of Priority Households notified by the 3(three) SDOs and their claims and objections should be submitted either to the 3(three) SDOs of Thoubal District or to the office of DC/Thoubal **on or before the 4th February, 2014 positively**, failing which no further applications/claims/objections will be entertained and the final list of the Priority Households will be notified accordingly as per the provisions of the National Food Security Act, 2013 and standing instructions of the State Government.
