
PRESS NOTE

Thoubal, the 15th May, 2015.

No 21/4/DC (DEO)/TBL/ELEC/SSR-2014: In connection with the ongoing National Electoral Rolls Purification and Authentication Programme (NERPAP) conducted as per direction of the Election Commission of India and in view of the 2nd Special Camp being organized on **17th May, 2015 (Sunday)** at all 368 Polling Stations of 10(Ten) Assembly Constituencies falling within the jurisdiction of DC/DEO, Thoubal, it is hereby notified for information of all concerned and other concerned Stakeholders that the **DC/DEO, Thoubal besides the SDOs/EROs, Sector Officers, Supervisors of Thoubal, Kakching & Lilong** will personally inspect a significantly large numbers of Polling Stations, whether the Booth Level Officers (BLOs) detailed for election duty are performing their assigned works or not. On this Special Campaign Day, besides collection of Aadhaar Cards for linking with EPIC data through National Voters Service Portal (NVSP), the duly filled in Forms – 6, 7, 8 and 8A may also be submitted by the electors as well as by the eligible voters direct to the BLOs concerned at their respective Polling Stations.

2. Further, it is notified that if any of the Officers/Officials (including BLOs) are found absent during the random checking of Polling Stations by the DC/DEO, Thoubal and concerned SDOs, necessary disciplinary action as deem fit under the rules/existing instructions of the ECI will be initiated **suo-motto** against those defaulting Officers/Officials without any further notice.

3. In order to ensure that the said Special Campaign is performed successfully, **a humble Appeal** is hereby made by the DC/DEO, Thoubal to all concerned more particularly to the elected representatives of PRIs, Local Bodies such Municipal Councils including Nagar Panchayats to kindly extend their maximum support and co-operation to the BLOs concerned. If any of the BLOs detailed for duty are found absent on this Special Campaign dated (17th May, 2015), specific written complaints may please be submitted to any of the following Officers viz, DC/DEO, SDOs/EROs, SDCs/AEROs, Sector Officers, Supervisors concerned so as to enable us to take up prompt disciplinary actions as deem fit against those defaulting BLOs.
