MEMORANDUM

Thoubal, the 6th August, 2016.

No.4/33/CAF & PD/TBL/NFSA/2013 (Pt.): Whereas, it has been brought to the notice of the undersigned that there have been allegedly reported cases of bogus, duplicate Ration Cards issued to the beneficiary households (both AAY & Priority) in respect of Thoubal District in connection with matters related to NFSA, 2013. Whereas, some Ration Cards are also reportedly not prepared for the genuine beneficiaries depriving their rights as given under the provisions of NFSA, 2013, thereby leading to submission of complaints to the office of the undersigned & DSO(CAF & PD), Thoubal;

2. Whereas, in view of above, there is an urgent need to rectify the defects/inadvertent mistakes (if any) and to redress the grievances as expressed by some complainants and in order to ensure proper implementation of NFSA, 2013 in Thoubal District; it has been decided to take up the following steps immediately on priority basis:

- i. *Those allegedly reported bogus, duplicate Ration Cards will be cancelled immediately after proper verification through concerned SDOs and DSO (CAF & PD)/Thoubal and no food grains/SK Oil should be issued to those Card holders by the concerned Rationing Agents/SK Oil Sub-Dealers;*
- ii. *Those Ration Card Holders (if any), who are not eligible under NFSA, to whom Ration Cards have already been distributed, should surrender their Ration Cards immediately to the office of DSO(CAF & PD), Thoubal at the earliest preferably on or before 22nd August, 2016 positively.*
- iii. *Those genuine/entitled persons/households, who are not issued any Ration Card till date should approach the office of DSO(CAF & PD)/Thoubal and they may submit fresh applications for their enrolment/preparation of Ration Cards and the required applications should be submitted to the office of DSO/Thoubal during office hours on or before 31st August, 2016.*
- iv. *As done in the case of Photo Electoral Rolls, every best effort will be made for continuous updation/entry of correct data/preparation/issue of Ration Cards to only those eligible households.*

3. For convenience of the general public of Thoubal District, the inclusion and exclusion criteria as prescribed by the State Government are reproduced below:

INCLUSION CRITERIA:-


The household having annual income of less than Rs.1.00 Lakh and fulfilling the following criteria will be considered as eligible household for inclusion in the AAY and Priority category as the case may be:

- i) *Household with disabled person (as defined in Persons with Disabilities Act, 1995) subject to submission of prescribed medical certificate,*
- ii) *Single women (including widows, unmarried and separated and deserted women), living in household as dependent or as head of household.*
- iii) *Children living without protection.*
- iv) *Person living with HIV.*
- v) *Occupationally vulnerable groups like unskilled construction workers, casual daily wages labour, casual domestic workers, cycle rickshaw drivers, unskilled workers in small households enterprises, unskilled workers in household industries.*
- vi) *Any other households having annual income of less than Rs. 1 Lakh per annum.*

EXCLUSION CRITERIA:-

Notwithstanding their fulfilling the inclusion criteria, the following households will not be eligible:

- i) *If any member of household owns a light (Four Wheeler) or heavy Vehicle.*
- ii) *If the household is receiving ration/ food subsidy under any other scheme.*
- iii) *If any member of the household is income tax payee.*
