

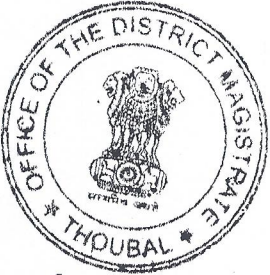

All licences of arms/weapons which have allegedly been mis-used and those who fail to deposit their licences along with weapons to Lilong Police Stations **will be cancelled without any further show cause notice** as per relevant provisions/sections of the Arms Act.
