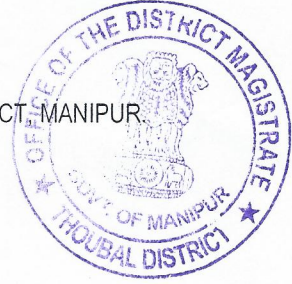

O R D E R S

Thoubal, the 30th August, 2014.

No. DC(TBL)/9/13/93/Arms(Misc)/2012 : Whereas, after the announcement of the By-Election Scheduled to the Kakching Municipal Council, Ward No.-7 (unreserved) by the State Election Commission, Manipur vide its Notice dated 19-8-2014, the prevailing law & order situation in Kakching Municipal Council, Ward No. 7 (seven) areas has been reviewed and examined minutely in view of the By-Election and the undersigned in my capacity as the District Magistrate of the District is fully convinced and satisfied that there are sufficient reasons/grounds for passing an appropriate order thereby directing the Licensed holders of Arms in the Ward No. 7 to deposit their licensed arms at the Officer-in-Charge, Kakching Police Station to ensure that no untoward / unwanted incidents occur during the conduct of the By-Election, 2014;

2. Whereas, it is considered necessary to withdraw all the licensed arms in the ward No. 7 and keep in the safe custody of Officer-in-Charge, Kakching Police Station having the jurisdiction where the residence of a licensee is located in view of the By-Election, 2014;

3. Now, therefore, I, Shri Ksh. Lemba Singh, District Magistrate, Thoubal in exercise of the powers conferred under Arms Act, 1959 do hereby order that all such licensee of Kakching Municipal Council Ward No. 7 shall deposit their licensed arms with immediate effect and until further order and also prohibit / ban carrying of licensed arms by individuals who are coming from outside the areas of the Ward No. 7 of Kakching Municipal Council in the aforesaid mentioned area as stated above with a view to maintain law & order and to ensure peaceful conduct of the By-Election.

4. Any individual who desires to appeal against this order may submit his/her written justification for retaining his/her licensed arms to the office of the undersigned during office hours on or before 3.00 p.m. of 03-9-2014.
