No 21/4/DC (DEO)/TBL/ELEC/SSR-2014: In connection with the launching of National Electoral Rolls Purification and Authentication Programme (NERPAP) by the Election Commission of India on 03-03-2015 and in pursuance of ECI letter No. 23/1/2015-ERS dated 27th February, 2015, it is hereby ordered that the following SDCs/AEROs falling under the jurisdiction of SDOs/EROs of Thoubal, Kakching and Lilong are hereby appointed as the Overall Sector Officers/Sector Magistrates for the Polling Stations mentioned against their names with immediate effect and until the ongoing NERPAP exercise is over. Further, it is notified that **a nationwide Special Camp** regarding the linking of EPIC with Aadhaar data through National Voters Service Portal (NVSP) will be organized at all the Polling Stations of 10 (ten) Assembly Constituencies of Thoubal District **on 12th April, 2015 (Sunday)**, where the BLOs concerned will be present.
