No. 1/6/DC(TBL)/2013/S-W : In/pursuance of D.O. letter No. 6/56/2013-S(SW) dated 09-09-2013 of Principal Secretary, (Social Welfare), Govt. of Manipur and as per direction of the Hon'ble Supreme Court of India vide its Order dated 07-02-2013 as passed in Writ Petition (CRL) No. 102 of 2007, it is hereby notified for information of all concerned that all Child Care Institutions (CCIs) are required to be registered under various provisions of the Juvenile Justice (Care and Protection of Children) Act, 2000. All concerned are requested to refer to Section-34(3) of Juvenile Justice (Care and Protection of Children) Act, 2000.

2. The Directorate of Social Welfare, Manipur is also taking up necessary follow up action to ensure that all Child Care Institutions (CCIs) located in the whole Manipur State are registered under the aforesaid Act, 2000.

3. The concerned District Social Welfare Officer, Thoubal has been instructed to carry out necessary inspection of the existing Child Care Institutions located within the jurisdiction of Thoubal District with the direction to obtain copies of the Registration (if any) by 10-10-2013.

4. Further, the District Social Welfare Officer, Thoubal has also been directed to ensure that all Child Care Institutions running within Thoubal District are duly registered at the earliest under the relevant provision of Act, 2000.

5. It is further informed that appropriate necessary actions as deem fit under the relevant provision of the Act, 2000 will be initiated against those Child Care Institutions which has not registered till date.

6. In view of the aforesaid direction of the Supreme Court of India, a sincere appeal is hereby made to all concerned Child Care Institutions to ensure that they are registered under the Act at the earliest.
